

ACEs Aware Trauma-Informed Network of Care Grants

On January 27, 2021, the California Department of Health Care Services (DHCS) in partnership with the Office of the California Surgeon General (CA-OSG) announced \$30.8 million in <u>ACEs Aware grant funding</u> awarded to 35 organizations across California to build and strengthen robust "networks of care" to effectively respond to Adverse Childhood Experiences (ACEs) and toxic stress with community-based health and social supports that meet the needs of children, adults, and families.

Two types of grants are being awarded: six-month Network of Care Planning Grants and up to 18-month Network of Care Implementation Grants.




Figure 1: Trauma-Informed Network of Care Grants

Applicants were asked to collaborate across their health care and social service communities to establish or augment a group of partners, including at least one Medi-Cal participating primary care provider, that will ultimately make up the Trauma-Informed Network of Care.
